Registered Nurse and Nurse Practitioner Educational Requirements Alignment with Other States Licensure

The U.S. Department of Education has implemented regulations (Regulation 34 CFR 668.43 (a) (5) (v)) which requires Wheeling University's BSN, MSN and Post-Master's Nursing Certification in Family Nurse Practitioner (FNP) Nursing Programs to provide a list of all states/jurisdictions where the institution's curriculum meets state educational requirements for professional licensure or certification.
