Please note that we may ask for additional documentation if we have reason to believe that the information provided is inaccurate. If you have questions about verification, contact us as soon as possible so that your financial aid will not be delayed.

Identity/Statement of Educational Purpose - At the Institution

The student must appear in person at Wheeling University to verify his or her identity by presenting a valid government-issued photo identification (ID) acknowledged in the notary statement below, such as a driver's license, other state-issued ID, or passport. The institution will maintain a copy of the student's photo ID that is annotated with the date it was received and the name of the official at the institution authorized to collect the student's ID.
